OUR GOLDEN RULES

We have clear aims and expectations to help us achieve a happy, safe and secure environment for all those who work in or visit our school. We have introduced Golden Rules to help us achieve our aims. These rules emphasise the positive:

Do be kind and helpful..	Don't hurt people's feelings
Do be gentle..	Don't hurt anyone
Do listen...	Don't interrupt
Do work hard...	Don't waste your or other people's time
Do be honest...	Don't cover up the truth
Do look after property...	Don't waste or damage things

To affirm the children in their positive behaviour, the children who observe these rules are given golden time, where they can choose an enjoyable activity.

ATTENDANCE

Schools are now required by law to keep a careful record of attendance.



AUTHORISED ABSENCE

We hope that parents will arrange to take their annual holiday during school holiday but if this is not possible a holiday request form, available from the office, should be completed.

UNAUTHORIZED ABSENCE

There are occasions when a child is late, or a note has been received giving a reason for absence, or days have been taken outside the scope of the regulations, e.g. occasional days out, holidays longer than 10 days etc. These are regarded as unauthorized absence.

PERMISSION TO LEAVE THE PREMISES

No child will be given permission to leave the school premises during the school hours without the written permissions/request of the parents and the agreement of the principal.

ILLNESS IN SCHOOL

If a child becomes unwell in school or we have any concerns over the result of the child's health parent s are contacted over phone. It is essential that the school has an emergency contact number of the parents.



BEHAVIOUR POLICY

“Good behavior is necessary for effective learning to take place.”

Within a school “family” some rules are essential; these are mostly matters of common sense to ensure the safety of our children. The emphasis in the school is to praise positive behavior, attitude and effort and to increase children's awareness of the need to make a positive contribution to their community.

We have a Behavior policy which is consistently applied by all adults who work in school and is outlined below:

AIMS

- We will strive to create a positive climate in which pupil's self esteem is nurtured and misbehavior becomes a less attractive way to gain attention.
- DPPS has such an environment where effective teaching and learning can take place.
- Everyone will work together to encourage good behavior.
- A high level of parental involvement is encouraged and expected.
- We will work closely with other agencies to ensure that children with complex needs and difficulties, and their families are given appropriate support.

DEALING WITH INAPPROPRIATE BEHAVIOUR

Our five simple school rules are:

- I will walk and talk quietly in our school
- I will be helpful and polite to everyone
- I will look at and listen to people who are talking to me
- I will look after everything in our school
- I will always try my best in everything that I do

Minor rule breaking will be ignored. Members of staff will provide attention to those who are behaving correctly. When pupils have to be reminded of the rules, this will be done quietly and calmly with the aim of getting the pupil back on task as soon as possible. The inappropriate behaviour will be criticized not the child.



DISCIPLINE

SCHOOL RULES

All children new to the school should be aware that the social environment may be very different to that at home. Large numbers of children working and playing together necessitate the imposition of rules of behavior to ensure the safety and well-being of each individual. Thus, while there exists no official list of regulations, each is, for example, expected to be polite to other pupils and visitors, exercise tolerance in relationships with peers: be prepared to offer assistance when and where it is needed, exercise initiative and show respect for others (adults and children). Children should also be receptive to the school's effort to develop his or her own esteem. From time to time it will be necessary for the teacher to issue instruction which may need to be acted upon promptly without question and the children should understand that, in such circumstances, the member of staff is acting either for the pupil's own benefit or with the general welfare of the school in mind. Thus although corporal punishment has been prohibited in country schools and voluntary controlled schools since September 1986, standards of discipline are high and other punishments of a non-physical nature may be imposed in cases of regular failure to comply with the school's code of behavior. The child's parents will be informed of the situation. They may subsequently be invited to attend a meeting with the Principal in order to determine how the parents may best support the school's effort to maintain the good standards of discipline for which the school is renowned.

THE SCHOOL DOCTOR

DELHI PUBLIC SECONDARY SCHOOL has a doctor, who visits periodically just to ensure if anyone needs special attention.

MEDICAL MATTERS

EMERGENCIES

When a child starts school, parents are asked to complete a form which allows them to give details of all allergies or relevant medical condition of which the school ought to be aware, together with a request for the telephone number of someone who may be contacted in the event of an emergency. It is essential that this form is fully complete if the welfare of each pupil is to be effectively provided for. All forms are regarded as confidential and information is kept in computer database. You must make every effort to keep this up-to-date. In cases where professional medical treatment is considered necessary after an incident at school, and is not possible to contact Parents. Then the child may be taken directly to either the local health centre or the hospital by a member





of staff. The child's parents will, of course, be informed of the situation as soon as possible. If child is on a regular medication (eg. asthma inhalers), the class teacher must be informed and the medicine must be kept by member of staff in a safe place away from the reach of other pupils, i.e. it must not be left in cloakroom areas, desks or trays. When after illness, a child returns to school requiring daily dosages to complete a course of prescribed medication, arrangements must be made to administer these. Teachers and support are not allowed by law to administer medicine.

SCHOOL BUS

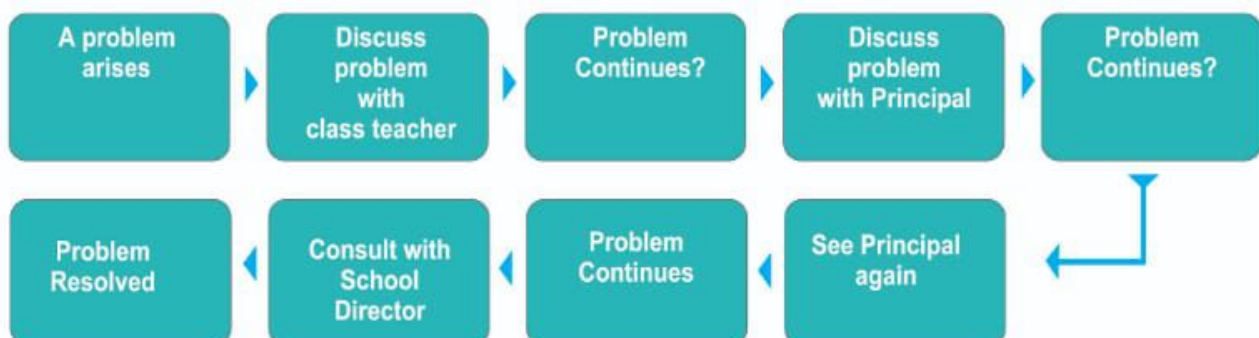
School buses will be provided to students coming from various areas of the city. The details of time and departure points will be made available at our school for the benefit of the Parents / Guardians.
